0110	RA	RA – Line No. 0110 – French Underdrain – Underrun: The location of the drain was moved slightly from the plan location and was shortened accordingly. The quantity represents the final field measured length.
0130	RA	RA – Line No. 0130 – Concrete Sidewalk – Overrun: Extra sidewalk squares were added to various locations at Angelica and 11th Street. This quantity represents the final field measured quantity.
0140	DF	DF – Line No. 0140 – Misc. ADA Concrete Curb Ramp – Overrun: An extra ADA ramp was added to the southwest corner of Angelica and 11th Street in order to accommodate pedestrian traffic in both directions.
